The Director welcomed the members and briefed the following measures taken by the college towards total prevention of ragging in the campus and in the college bus

1. Based on the previous meeting discussion, the display board where fixed in all the places to create the awareness about ragging and its punishments.
2. It is suggested to follow the regular practice of addressing all the senior student's year wise and sensitizing them regarding the need for total prevention of ragging, followed by presentation by the Nodal officer, describing the rules and regulations established by the UGC, AICTE, University and other statutory bodies of the state and central governments, pertaining to ragging in educational institutions.
3. Regular monitoring of discipline in the campus by the entire Hod's Anti Ragging Squad, Camps monitoring and Faculty members and staff.
4. The Director also mentioned that in view of the stringent measures being adopted over the years, so far no incident of ragging has occurred.
5. During initiation day, the first year students are informed of the support systems including the list of officials to be contacted along with their e-mail Ids and Phone numbers, in case they wish to report any kind of ragging encountered by then. This practice will be followed this year also on the induction day.
